CLC provides two forms of free transactional legal services to eligible small businesses:

- Brief Advice Hotline
 30 minutes or less
- Direct Representation Tolonger than 30 minutes

† It often takes at least 4 weeks to find volunteer attorneys for Direct Representation matters.

Who is eligible?

CLC has limited capacity to provide legal support. We generally only support small businesses that:

- have a Chicago business address
- sell a product or service
- have 5 or fewer employees
- have annual revenue less than \$500,000 per year
- are referred by one ofCLC's communityorganization partners
- have a transactional legal need (we cannot help with disputes or litigation)

If your small business meets these criteria, please apply for legal services online so CLC can assess your eligibility.

How do I apply for legal services?

If your legal need will take 30 minutes or less, complete our brief advice intake.

FINANCIAL DISTRESS/DISSOLUTION/BANKRUPTCY

FINANCING

 Review/Representation to understand loan documents, close a business loan

INSURANCE*

 Income Disruption and Questions about insurance policy coverage for businesses that have ceased operations (COVID-19 impact only)

*Brief advice only, not comprehensive insurance policy coverage review

- Drafting a non-disclosure agreement

- Protecting the name and logo of the business
- Protecting work created by the business
- Protecting trade secrets
- Determining ownership of work created by an employee or independent contractor
